



## Transferable Warranty Terms and Conditions

### 2015 and Newer Model Years

#### 10-Year Limited Transferrable Hull Warranty

**Clearwater Sport Fishing** is pleased to offer a limited transferrable hull warranty for their boats. This insures to our boat owners that each hull is free from defects in materials and workmanship, under normal care and use, for a period of **ten (10) years** from the original date of purchase. Clearwater agrees to repair or replace, to the purchaser, any boat that is found to be defective during the applied warranty period. This is at our discretion, based on a review by our representatives of the hull in question. Costs for approved repairs follow the warranty depreciation schedule:

*One (1) year after purchase—90% covered*

*Three (3) years after purchase—75% covered*

*Five (5) years after purchase—50% covered*

*Seven (7) years after purchase—25% covered*

#### Other Warranties

Except for components expressly mentioned herein, all other components from different manufacturers or vendors will follow the original manufacturers' warranties. Damaged or defective components must be reported immediately upon discovery to the original Clearwater dealer the boat was purchased from. The authorized dealer will notify Clearwater of repairs and replacement parts that may be needed. The original defective or damaged parts must be returned to Clearwater.

#### 3 Year Protection:

**Steering** - Helm, hoses, cables, hydraulic cylinders and steering wheel.

**Electrical** - Switches, wiring harness, LED lights, battery switches, bow light (excluding bulbs), horn, anchor light, 12 V receptacles, duplex outlets, trim tabs, stereo, stereo remote, windlass, and live well lights.

**Fuel Delivery** - Fuel tank, fuel vent, fuel hoses, water separator (excluding filter), and fuel fills.

**Controls** - Shift and throttle cables.

**Accessories** - Ladder, windshield, rod holders, tackle boxes, gas shocks, anchor chute, cleats, T-top, hardtop, outriggers, thru-hulls, rub rail, bow/ stern eyes.

#### 1 Year Protection:

**Electrical** - Wiring and exhaust system, macerator, livewell, freshwater, bilge and wash down pumps, and float switches.

**Upholstery/ Canvas** - Vinyl, stitching, workmanship

### **Obtaining Repairs Under Warranty**

During the period of the warranty, Clearwater or its authorized representatives may repair or replace at its sole discretion any part adjudged defective by Clearwater due to faulty workmanship or material from the factory provided the original owner returns the boat, with transportation prepaid to authorized Clearwater dealer, or if necessary to the Clearwater factory or any other authorized place designated by Clearwater. Should Clearwater elect to replace the entire boat or any part thereof, i.e. deck or hull, the replacement boat shall be subject to the remaining duration and conditions of this warranty are not subject to an extended or new warranty unless otherwise provided for by both parties in writing. The liability of Clearwater shall in no event exceed the actual cash value of the covered item. The boat owner will be responsible for all transportation, loss of time, travel expense, loss of use, launch, towing, storage, and other expenses incurred in returning the boat for warranty service. All parts replaced under warranty shall become the property of Clearwater Sport Fishing.

Clearwater reserves the right to improve its product through changes in design or material without obligation to incorporate such changes on boats built prior to the implementation of the respected changes.

### **Exclusions from Warranty**

- Any boat which has been powered or loaded in excess of the manufacturer's maximum horsepower or capacity recommendations. The maximum horsepower and capacity recommendation are shown on the certification plate affixed to every boat.
- Any boat used in or for racing (of any type, organized or not), commercial fishing, chartering or other commercial use.
- Any boat which has been subject to misuse, neglect, or structural alterations.
- Gelcoat cracking, crazing, bubbling, or blistering.
- Excessive wear due to unprotected and/or overexposure to the sun and elements.
- Any fuses, bulbs, switches or the failure of any electrical component due to corrosion or failure to use correct wattage.
- Any boat that has been deemed to have been misused, neglected or re-powered by anyone other than the original purchaser.
- Any boat that has been used on a trailer that does not adequately support the hull or any trailer that may be considered undersized, including any and all roller type trailers.
- Any boat with a jack plate installed by anyone other than Clearwater, or an authorized dealer.
- Powder coated parts must be maintained by the owner. If powder coated parts chip or flake then owner must repair to prevent oxidation; Clearwater can give guidance on repair.
- Any part or component not manufactured directly by Clearwater after the first three years of this warranty policy, (three years from the date of purchase), will only have that particular manufacturer's warranty available.

**Warranty Services / Customer Responsibilities**

In order to receive warranty service, the selling dealer must return the registration card at the bottom of this sheet within 30 days of sale, and the purchaser must take his/her boat to an authorized Clearwater dealer. Depending on the nature of the claim, Clearwater may require the boat be returned to the factory at 450 Brown Avenue, Columbus, Ga., 31906 in which case all transportation, haul-out, and/or loading charges shall be prepaid and the sole responsibility of the purchaser. Clearwater may choose to reimburse up to one half of such transportation charges to the original purchaser upon the discovery of a valid and applicable warranty claim that is a direct result of improper manufacturing processes on the part of Clearwater or one of our suppliers. The original purchaser must remove and reinstall at his/her expense, all outboard engines, (if directly related to damage in question), as well as any and all personal effects and electronic equipment. The decision to repair, replace or make reimbursement for a particular boat or part shall be at the discretion of Clearwater.

On-line registration, a bill of sale, or proof-of-purchase demonstrating individual in question as the purchaser, along with proof of the customer's identity, is required before warranty service can be rendered.

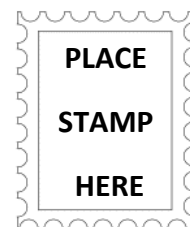
**Warranty Transferability**

This warranty is transferable, and to do so the original owner must download a copy of the warranty transfer form from [www.clearwater-boats.com](http://www.clearwater-boats.com) or [capecraft-boats.com](http://capecraft-boats.com) from the warranty section of the website and mail it to Clearwater within 10 days of the sale of his/her boat to the new owner. A notarized bill of sale and a \$200 administration fee payable Clearwater Sport Fishing must also be included.
